Crating and Shade shelters are not permitted within close proximity of the ring (ie within 20 feet of the sides or the rear of the ring and should be at least 40 feet from the front of the ring.) This is to keep the Marshalling area clear and to provide teams competing with clear ring perimeters.

Move ups:

No Move ups as it is a single day trial

Day of show Entries:

Available after closing if the trial is not full.
Please refer to trial entry limits.

Refunds:

A full refund will be available if the withdrawal request takes place prior to the entry closing date.

Partial refund or trial credits of 75% if requested after the entry closing date and prior to the trial day if your dog is ill or injured- a vet certificate is required.

No refunds are given on a trial day.

Volunteer info:

Blissful Paws trials rely on the help from all exhibitors entered. Exhibitors are rostered a small number of jobs such as Timer, Scorer, Scribe, Leash walker and Jump pole setters

Awards and Ribbons:

Ribbons Awarded from 1st to 4th place for all classes in each height group in Standard Division.

Ribbons Awarded from 1st to 4th place for all classes in each height group in combined Junior Handler, Veteran Dog and Veteran Handler Division.

Qualifying ribbons will be awarded for all qualifying runs. Exhibitors may elect to have trial credits in lieu of ribbons - \$1.00 per Q and 40 Cents per place – this option is made available at the time of entry.

Highest in Trial will be awarded for each level Intro, Novice, Open, Elite in both standard and veteran classes

JUMP HEIGHTS

There are four Standard Division-Proficient jump heights: 8", 12", 16", and 20".

There are four Standard Division-Skilled jump heights: 4", 8", 12", and 16".

There are four jump heights for the Veterans and Junior Handler divisions: 4", 8", 12", and 16".

Brief Summary of Rules:

Please refer to www.nadac.com for a full explanation of all NADAC rules and up to date information.

- Please note that NADAC trials should provide a safe and fun environment for both exhibitors and their dogs.
- Aggressive dogs will not be tolerated and will be excused from the trial.
- The show committee has the right to refuse any entry. Anyone not currently in good standing with NADAC will not be allowed to enter this trial.
- Exhibitors, through submission of entry, acknowledge that they are knowledgeable of NADAC rules and regulations, and agree to abide by all rules in effect at the time of this trial.
- No entry fee will be refunded if the trial cannot open or be completed by reasons of riots, civil disturbances, fire, acts of God, public emergency, an act of a public enemy, or any other cause beyond the control of the organizing committee.
- Checks not honored by the bank do not constitute a valid entry fee. There will be a \$25.00 service charge for bank returned checks.
- Dog must be registered and have a valid registration number before entries will be accepted. www.pawstoconsider.formstack.com/forms/nadac_dog_registration A copy of the current Exhibitors Handbook may be downloaded free from the NADAC web site: www.nadac.com
- Bitches in heat, lame, or blind dogs are ineligible for entry, as is any dog with a deformity which may cause a judge to not be able to reasonably assess the dog's ability to function and perform agility obstacles safely, and in a manner that is in the best interest, health and welfare of the dog.
- No collars, leads, food, toys, clickers, or other aids or devices shall be permitted on the course. No, food, toys, clickers within 10 feet of the ring. Food or small toys can be in a secure container in pocket during a containerized trial.
- The sponsoring clubs will not be responsible for the loss or damage to any dog exhibited, or for the possessions of any exhibitor whether the result be accident or other cause. It is distinctly understood that every dog at this event is in the care and control of his owner or handler during the entire time the dog is on the show premises.

AGREEMENT

AGREEMENT- This agreement will be on the online form for you to sign electronically. Your entry cannot be processed without a signed agreement.

The person who signs this agreement represents that he/she is authorized to enter into this agreement on behalf of both exhibitor and the owner of entered dog. In consideration of acceptance of this entry:

- 1.1. As used here "NADAC" means the North American Dog Agility Council, LLC., its members, officers, directors, employees, show chairs, show committees and agents.
- 1.2. Exhibitor/owner agree to abide by the rules and regulations of NADAC and any other rules and regulations appearing in the premium for this event.
- 1.3. Exhibitor/owner certify that the entered dog is not a hazard to persons, dogs or property and that the entered dog's rabies vaccination is current in accordance with the requirement of the state in which the dog resides.
- 1.4. Exhibitor/owner acknowledge all hazards presented by the event and the event premises, including, but not limited to, the condition of the surface, restrooms, security measures or lack of, electrical appliances, fittings, show rings, parking areas and the presence of unfamiliar animals and people; exhibitor and owner assume the risk of any harm arising from these.
- 1.5. Exhibitor/owner releases NADAC (including its respective officers, directors, employees, and members), Blissful Paws (including its officers, directors, members, and event organizing committee), Paws to Consider (including its officers, directors, members) and City of Greater Geelong (including its officers, agents, and employees) and will defend them and hold them harmless from all present and future loss, injury, damage, claims, demands and liabilities involving the entered dog, the event or event premises. Without limiting the generality of the foregoing hold harmless provisions, exhibitor/owner hereby specifically assumes sole responsibility for and agrees to indemnify and save the aforementioned parties harmless from any and all loss and expenses (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damages because of bodily injuries, including death, at any time in consequence of my (our) participation in this event, howsoever such injury or death may be caused and whether or not the same may have been caused or may have been alleged to have been caused by negligence of the aforementioned parties or any of their employees or agents or any other persons

Club Policies

All dogs must be on leash when not competing in the ring. Dogs may not be left tethered and unattended on Trial grounds.

A class running order will be posted on a whiteboard ringside. There will be no posted exhibitor run order, exhibitors are invited to line up as they wish within their class. You will need to be attentive to what is happening in the ring as no-one will be calling for you. There will be a catalogue of entries available ringside if you have forgotten what you have entered.

Handlers are responsible for ensuring that they are ringside and ready to run their dog at an appropriate time.

No Alcoholic Beverages are allowed on the show site.

There will be no refunds for entries in the event a dog and/or handler are dismissed from competition regardless of the reason for such dismissal.

All exhibitors upon entering this trial agree to assist with the running of the trial. A Job Roster will be posted on the running order board. If exhibitors come out and help then the trial will run quite efficiently. If no one helps then as main workers get tired, the trial will run late and slow. We appreciate your help and thank you in advance.
